1. The appellant who is expelled as a trading member of National Stock Exchange of India Limited ('NSE' for short) pursuant to an order passed on January 5, 2006 has filed the present appeal to challenge the decision of Defaulters Committee of NSE dated December 4, 2014. By that decision the

Committee has declined to return the withheld securities deposited by the

appellant with the National Securities Clearing Corporation Ltd. (NSCCL)

unless the appellant gives a bank guarantee to the extent specified therein.

2. By this Misc. Application the appellant seeks to implead ITC Limited

as a party respondent to the appeal and also seeks an order restraining ITC

Limited from transferring the withheld securities in the name of third

parties.

3. None appear on behalf of ITC Limited though the notice is served

upon them. Counsel for NSE has no objection if the reliefs as prayed for are

granted.

4. In these circumstances, Miscellaneous Application is allowed by

permitting the appellant to implead ITC Limited as respondent no. 2 to the

appeal and ITC Limited is restrained from transferring the withheld

securities furnished by the appellant and lying with NSCCL till the hearing

and final disposal of the appeal. NSE is directed to communicate a copy of

this order to ITC Limited.

5. Misc. Application is disposed of in the above terms with no order as

to costs.
