- 1. The present appeal has been filed challenging the order of the Whole Time Member dated 23rd July, 2018 as well as the attachment order dated 2nd August, 2021 issued by the Recovery Officer. There is a delay of 1100 days in the filing of the appeal. The ground urged is that the appeal could not be filed as the directions given by the WTM were not possible to comply.
- 2. In our view, the ground urged is not sufficient to condone this inordinate delay. We do not find any

sufficient cause being shown to condone the inordinate delay. The appeal in so far as the order of the WTM is concerned is admittedly barred by time and consequently the appeal is dismissed on the ground of laches. Misc. application no.1371 of 2021 is disposed of accordingly.

- 3. In so far as the order of attachment is concerned the same has been issued pursuant to the direction issued by the WTM. Admittedly, till date the direction has not been complied with. The impugned attachment order thus does not suffer from any error of law. The appeal fails and is dismissed with no order as to costs.
- 4. The present matter was heard through video conference due to Covid-19 pandemic.
