## <u>O R D E R</u>

## Per: Justice P.S. Dinesh Kumar, Presiding Officer (Oral)

Learned advocate on both sides submit that after filing these appeals, SEBI<sup>1</sup> had issued a clarification dated February 17, 2025, which reads as follows :-

"<u>B. Noticees 1 to 5 and 7 to 19</u> are hereby restrained from buying, selling or dealing in securities, or accessing capital market either directly or indirectly, in any manner whatsoever until further orders.

D. The alleged unlawful gains as detailed in para. 28 above, accrued to Noticees 7 to 19 from sale of preferentially allotted shares as part of a primafacie fraudulent scheme, are impounded.

E. Banks where the Noticees 7 to 19 are holding bank accounts, including joint accounts, are directed that no debits in their accounts shall be made without permission of SEBI. Further, the Depositories are also directed that no debit shall be made without permission of SEBI in respect of the demat accounts held by the aforesaid persons. However, credits, if any, into the accounts may be allowed. Further, debits in the bank accounts may be allowed for amounts available in the

account in excess of the amount to be impounded. Banks are allowed to debit the accounts for the purpose of complying with this Order. Banks and the Depositories are directed to ensure that all the aforesaid directions are strictly enforced.

In view of the above directions by SEBI, it is advised that Banks, MIIs and SEBI Intermediaries shall reverse all such actions which have not been mentioned / inconsistent with the directions in the said interim Order. It is advised that the needful shall be done on most urgent and priority basis."

2. The issue involved in these appeals is, that the SEBI had directed the appellants' herein not to deal with BGDL<sup>2</sup>. However, grievance of the appellant is that their demat accounts and bank accounts have been frozen. Appellants have no grievance with regard to the direction and undertake to trade in the aforesaid scrip. Their contention is that the bank accounts and demat accounts ought not to have been frozen as they cannot trade in other scrips and they are deprived of their livelihood.

3. Shri Abishek Venkatraman, learned advocate submits that after issuing the clarification dated February 17, 2025, nothing survives in this appeal. Shri Bhushan Shah, learned advocate for the SEBI also submits that demat and bank

accounts have been defrozen. Therefore, nothing survives in these appeals.

4. In view of the above, these appeals are dismissed as infructuous.

5. All (pending) interlocutory application(s) stand disposed of.
