ORDER:

For the reasons stated therein, the application for condonation of delay is allowed. Delay of 34 days is condoned. The Misc. Application No. 1178 of 2025 is disposed of.

- 2. The application for exemption is allowed. Misc. Application No. 1179 of 2025 is disposed of.
- 3. Admit.
- 4. Respondent is granted six weeks time to file a reply and three weeks thereafter to the appellant to file rejoinder, if any.
- 5. Shri Abishek Venkataraman, learned Advocate for the appellant submits that the investigation period is between February 01, 2022 and December 31, 2022. The impugned order debars the appellant for a period of two years from

the date of the interim order dated February 08, 2024 from accessing the securities market. He submits that the appellant has suffered the debarment for a substantial period and also deposited 50% of the penalty amount. Therefore, the remaining period of debarment may be stayed. The said prayer is opposed by Shri Shiraz Rustomjee, the learned Senior Advocate for the SEBI.

- 6. Having regard to the fact that appellant has suffered debarment for substantial period, the impugned order shall remain stayed subject to deposit of 50% of the penalty amount within six weeks from today. The same shall be kept in an interest-bearing account by SEBI.
- 7. By consent, call on 28.01.2026.
