2. It is pertinent to mention that an order dated Sept 1, 2016 was passed by Adjudication officer imposing penalty of Rs 3,00,000/- wherein 45 days were given for payment of penalty amount. The order was duly served on Sept 9, 2016 and no steps have been taken to pay the penalty amount by the defaulter till date. Whereas, there is sufficient reason to believe that the defaulter may dispose off the amounts/ proceeds in the Bank/ Demat and Mutual Fund accounts held with Banks, Mutual Funds and Depository Participants and therefore, realization of amount due under the certificate would in consequence be delayed or obstructed.
