## Dear Sir/Madam,

Subject: Remittance of attached amounts vide Attachment proceeding No. 4493 and 4494 of 2019 of Bank / Demat Accounts and Mutual Fund Folios

- It may be recalled that the Recovery Officer vide the subject attachment proceedings in Recovery Certificate No. 2093 of 2019 dated April 23, 2019 had directed attachment of bank / demat accounts and mutual fund folios of i) Ms. Sangeeta Sethia (PAN-ARHPS2827H), ii) Mr. Swaminathan Rajendran (PAN- AIGPR6377P) and iii) Mr. Prabhat Sethia (PAN- AREPS7605L) [collectively referred to as "Defaulters"] against the total due of Rs.2,05,46,753/- (Rupees two crore five lakh forty six thousand seven hundred and fifty three only) with further interest, all costs, charges and expenses, etc.
- 2. Whereas a Notice of Demand dated April 23, 2019 has been sent to the Defaulters demanding payment of the aforesaid dues. However, as payments were not made, Notices dated May 23, 2019 for Attachment of Bank/Demat Account and Mutual Fund Folio(s) has been issued to you.
- 3. Whereas the current outstanding dues from the Defaulters in respect of the aforesaid Notice of Demand as on date amounts to **Rs. 2,18,94,699/-** (Rupees two crore eighteen lakh ninety four thousand six hundred and ninety nine only).
- 4. In view of the above, you are hereby directed to
  - i) remit amount to the extent as mentioned in para 3 above lying in the bank accounts of the defaulters held with your bank; and
  - ii) redeem the units of mutual funds held in the name of the defaulters and remit the amount to the extent as mentioned in para 3 above,

forthwith to SEBI by way of EFT/NEFT/RTGS to A/c No. 012210210000013 of Bank of India, Bandra Kurla Complex, Branch) [IFS Code- BKID0000122] immediately and intimate the remittance details by email to <u>recoverysro@sebi.gov.in</u> in the format as given in table below.
