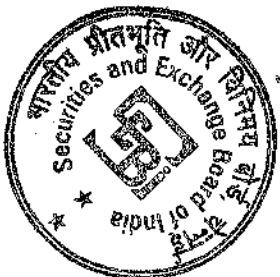

1.
