# Recovery Certificate No. 3168 of 2020 issued in the matter of Sanghi Plantations Limited

Order under Rule 16 and 48 of the Second Schedule to the Income-tax Act, 1961 read with Section 28A of the Securities and Exchange Board of India Act, 1992

- 1. Recovery proceedings was initiated by the Securities and Exchange Board of India ("SEBI") vide Recovery Certificate No. 3168 against
  - i. Sanghi Plantations Limited (CIN: U20299TG1991PLC013166),
     Address No.1: 4-3-352, Bank Street, Hyderabad 500095 (T.S).
     Address No.2: 4-4.341, Girikunj, 2nd floor, Giriraj Lane, Sultan Bazar, Koti, Hyderabad 500 095 (T.S)
  - ii. Mr. Kodhaty Chandrasekhar Rao (DIN: 02093535)
     Address: Flat No. 116, Plot No.3, Suryasaroj Apartments, HUDA Complex Kothapet, Hyderabad 500 035 (T.S.)
  - iii. **Mr. Seshadri Upadhyayula** (PAN: AAMPU7647R)

    (collectively referred to as "**defaulters**")

in view of their default in complying with the SEBI direction, made vide Order No. WTM/GM/EFD/65/2017-18 dated October 17, 2017, to jointly and severally, refund the monies collected under the schemes with returns which are due to the investors as





per terms of offer. In pursuance of the recovery proceedings, a Notice of Demand dated December 03, 2020 was issued to the aforesaid defaulters and the amount due from these entities as per the Notice of demand dated December 03, 2020 was Rs.2,07,27,000/-, and they were also liable for payment of returns/interest (as per the terms of the schemes) along with recovery cost. Since the defaulters failed to satisfy the Recovery Certificate and the notice of demand, SEBI issued attachment notices dated April 08, 2021 in attaching the bank accounts, demat accounts and mutual fund folios of the defaulters.

2. SEBI is recently made aware that the defaulter, <u>Sanghi Plantations Limited</u> is in possession/owns the following properties at Village: Koheda, Mandal: Abdullapurmet, District: Ranga Reddy, in the State of Telangana:

3. Considering the public interest involved in the matter, it becomes important for SEBI to take all possible measures to recover the dues from the defaulters. It also needs to be ensured that the defaulter does not dispose or transfer or alienate the assets with a view to obstruct or delay the recovery proceedings. Accordingly, it becomes necessary to attach the aforesaid properties of the defaulter Sanghi Plantations Limited including the





properties of other defaulters namely, Mr. Kodhaty Chandrasekhar Rao, Mr. Seshadri Upadhyayula and Mr. Benda Ram Narayan.

- 4. In view of the foregoing, and to ensure that investor's interest is protected, in exercise of the powers conferred under Rule 16 and 48 of the Second Schedule to the Income-tax Act, 1961 read with Section 28A of the SEBI Act, the defaulters, are hereby prohibited from disposing, transferring, alienating, or charging any or all of their immovable properties including those mentioned at Paragraph 2 above.
- 5. It is further directed that all persons are hereby prohibited from taking any benefit under such disposal, transfer, alienation or charge in respect of the properties of the defaulters including those mentioned above, which stand attached in execution of the Recovery Certificate No.3168/2020 drawn up against the aforesaid defaulters.
- 6. The concerned Sub-Registrar Office is directed to provide certified copies of the sale deeds/document evidencing the above said land under the survey nos. which stood registered as mentioned above in paragraph 2 above. Copies of the Pahani/Pattadar, as received by SEBI, are attached herewith for ready reference.
- 7. This Order shall be served on the defaulters and to
  - i. The Inspector General of Registration of the State of Telangana; and
  - ii. The concerned Tehsildars, District Registrars and Sub-Registrar of the respective areas where the above properties are located,

with a direction not to act upon any documents purporting to be dealing with transfer, mortgage, charge, lease or creation or alteration of any interest in any of the properties owned / held by the defaulters, including the afore-mentioned properties, if presented for registration.





8. The Inspector General of Registration of the State of Telangana is requested to direct the concerned Tehsildars, District Registrars and Sub-Registrars, under his jurisdiction, to provide details of any other property that may be held in the names of the defaulters, so as to aid SEBI in the recovery proceedings.
