WTM/SM/ERO/ERO/9172/2021-21 dated 25.09.2020 in the matter of Rainbow Industries and Constructions Limited., Recovery Proceedings have been initiated against Mr Nand Lal Koiree (PAN: AREPK5807E), Mr Ashok Saw (PAN: BLXPS0512A), Mr Mukesh Singh (PAN: BNVPS8079L) and Mr Ganesh Thakur (PAN: AFOPT8328K) [Defaulters], for recovery of the above amount, with the above mentioned defaulters and a Notice of Demand dated 22.07.2021 has been issued to them, in the matter.
- 3. And whereas there is sufficient reason to believe that the defaulters may withdraw the amounts/dispose of the securities in the accounts held with you and realization of the amount due under the certificate would in consequence be delayed or obstructed, I hold that in order to protect the interests of investors, it is necessary to attach the assets of the defaulters including the bank & demat accounts and mutual fund investments, to prevent any alienation of the same.
