1. Whereas a Recovery **Certificate No.228 of 2014** dated 11/07/2014 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs.1,28,386/- (Rupees One Lakh Twenty Eight Thousand Three Hundred and Eighty Six Only) along with further interest, all costs, charges and expenses etc. against **Mukund Yadu Jambhale (PAN: AHCPJ1271D) ["Defaulter"]** and the same is due from him in respect of the said certificate. A Notice of Demand dated 11/07/2014 has been issued to **Mukund Yadu Jambhale**. It may be noted that the amount outstanding in the instant RC as on date is Rs.2,19,000/- (Rupees Two Lakh Nineteen Thousand Only).
2. And whereas there is sufficient reason to believe that the the securities in the Mutual fund folio/s held with you may be disposed of and realization of amount due under the certificate would in consequence be delayed or obstructed.
2. It is, therefore, in exercise of powers conferred on me, I hereby order to attach the following with immediate effect :

3. It is further ordered with immediate effect that **No Debit** shall be made in the said folios until further orders. However, the credits, if any, into the account may be allowed.
4. You are hereby directed to provide the following immediately to the undersigned/our representative on service of this Notice.
 - a) Details of all the Accounts/folios held by the defaulter with you; either singly or jointly with any other person/s,
 - b) Copy of the Account Statement/s; and
 - c) Confirmation of Attachment of the said accounts/folios
