Whereas Recovery Certificate No. 8673 of 2025 dated March 17, 2025 was drawn against Amtek Auto Ltd - Now known as Revent Precision Engineering Limited [Defaulter] PAN: AAGCA4447E in the matter of Castex Technologies Ltd. and a sum Rs. 41,05,000.0/- (*Rupees Forty-One Lakh Five Thousands Only*) was due under the said certificate along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum.
2. And whereas Notices of Attachment dated May 22, 2025 under the above proceedings were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
3. And whereas SEBI has recovered the amount of Rs. 41,53,000/- (*Rupees Forty-One Lakh & Fifty-Three Thousand Only*) which includes interest and costs towards full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Amtek Auto Ltd - Now known as Revent Precision Engineering Limited (PAN: AAGCA4447E) attached, if any, pursuant to the above notices of attachment with immediate effect.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
